



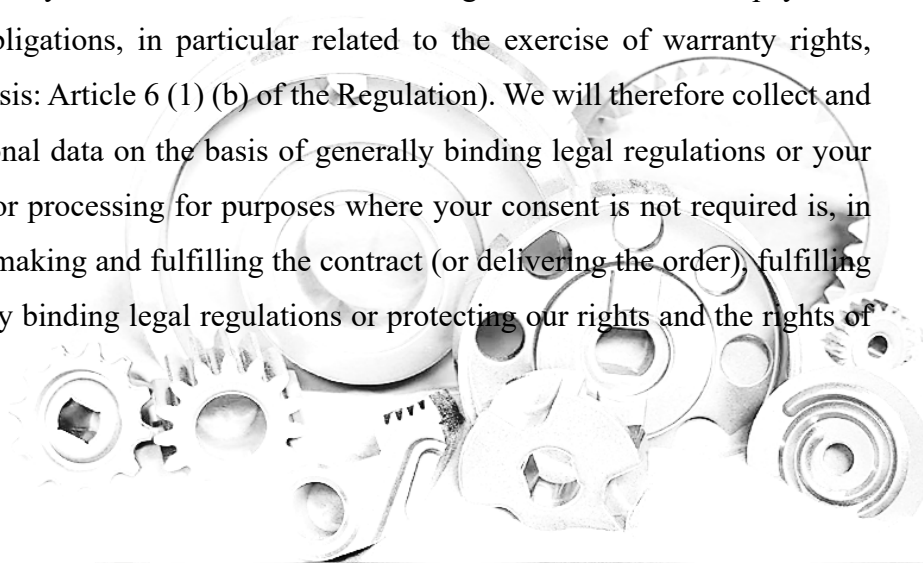
## NOTICE TO BUSINESS PARTNERS, SHAREHOLDERS AND THE PUBLIC ON THE PROCESSING OF PERSONAL DATA

Protecting your privacy is high priority for us. This privacy notice explains what personal data we process, how we process it, and to whom personal information is provided or made available.

### Please read this Notice carefully!

Company GEVORKYAN, a.s. so sídlom: Továrenská 504, Vlkanová 976 31. IČO: 36 017 205, zapísaná v Obchodnom registri, Okresného súdu Banská Bystrica, Oddiel Sa, vložka číslo: 1232/S (hereinafter referred to as "the Company"), processes your personal data as an controller in the scope and under the terms of this notice. When processing your personal data as an information system controller, we only act in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, repealing Directive 95 / 46 / EC (General Data Protection Regulation, hereinafter referred to as "the Regulation") and Act No. 18/2018 Z. z. on the Protection of Personal Data (hereinafter referred to as the "Act").

In order to conduct a business relationship with you, we need to process some of the personal information necessary to make a contract, deliver the goods/service, make a payment, fulfil other contractual obligations, in particular related to the exercise of warranty rights, claims, and so on (legal basis: Article 6 (1) (b) of the Regulation). We will therefore collect and further process your personal data on the basis of generally binding legal regulations or your consent. The legal basis for processing for purposes where your consent is not required is, in particular, the purpose of making and fulfilling the contract (or delivering the order), fulfilling obligations under generally binding legal regulations or protecting our rights and the rights of protected interests.





If we process your data on the legal basis of Art. 6, par. 1 letter a) Regulations - consent to processing, we process your data exclusively under the conditions and for the purposes for which you have given us consent. Such purposes are mainly: **advertising, marketing and promotional activities of our Company, sending the newsletter.**

According to this announcement, we will process in particular the following personal data:

- *name, surname, positions if relevant, full business address;*
- *data concerning natural person representing the legal person, provided directly by natural person or obtained by public sources;*
- *in case of the natural person who is the entrepreneur, the other official register in which that trader is registered, the number of the entry in that register or record and data related to invoicing and payments (tax code, bank data);*
- *contact phone number, fax number and e-mail address;*
- *data of Your personnel who performs assembly, service or equipment repair in our premises, related to the payroll, social, pension and insurance contribution only;*
- *other personal information we need to process in accordance with the stated purposes.*

Based on your written request, we will let you know what other personal information we have kept about you. We do not process your personal data for marketing purposes.

We collect your personal information directly from you and it will be stored safely throughout processing in accordance with our security policy. The processing of your personal data takes only the time necessary to meet the purpose of the processing in accordance with the statutory deadlines and time limits set by the registry and archive rules. In the event that we process your data on the basis of your consent, we will process this data only for the duration of this consent, unless we are required by generally binding legal regulations to keep this data even after your consent has been revoked.

It is our duty to protect the privacy of our website users as well. When you visit our website, our web servers for security reasons always retain the linking data of the computer connecting





with our site, the list of websites you visit within our site, the date and duration of your visit, the identification information of the type of browser used and the operating system as well as the website through which you link to our site. We use tracking software to determine how many users visit our site and how often. We do not use this software to collect personal data or individual IP addresses. These data are used exclusively in anonymous and aggregated form for statistical purposes and for the development of a website. Additional personal information such as name, address, telephone number or email address is not collected unless you provide this information on a voluntary basis, when you directly fill out the contact form as part of the registration or information request.

The Company does not share, sell, transmit, or otherwise disseminate your personal information to third parties, and will not do so in the future unless the law so requires, unless it is required for the purpose of the agreement or unless you explicitly agree to do so. For example, it may be necessary to give your address and order details to third parties providing transportation. The Company has the legal obligation to provide your personal data, in particular, for inspection, surveillance or at the request of the competent authorities of the State or the Institutions, as required by special regulations.

For the purpose of fulfilling the contract and using cookies, it is necessary to provide your personal data to the following third parties:

- technological service providers,
- providers and collaborators in the field of logistics, transport and delivery,
- providers and collaborators in the field of services related to marketing and advertising.

In accordance with the Regulation and if the generally binding legislation does not stipulate anything else, you have the right to:

- **access** to your personal data and the right to obtain a **confirmation** that we process your personal data and, if so, what kind of personal data we process, for what purpose, for what time and other details regarding in particular the controllers, intermediaries and other entities, which data may be provided;







- **withdraw** your consent whenever your personal data is processed under your consent;
- ask for your personal data to be **corrected** or **updated** so that it is always accurate and up-to-date;
- the **deletion** of your personal data until the expiration of the legal processing period;
- to **limit** the processing of your personal data, for example, when you have questioned the accuracy of your personal information during a period that allows us to verify its accuracy;
- **get your personal information in electronic form** that you have provided us for yourself or for another operator;
- file a **complaint** with us and / or with the Office for Personal Data Protection of the Slovak Republic.

Information about cookies:

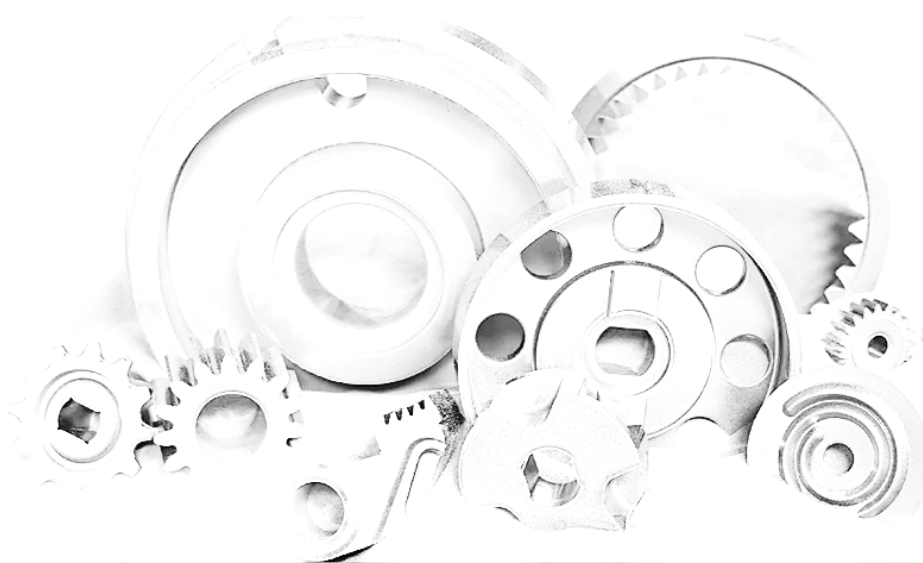
A "cookie" file is a small text file with information about your navigation on the site, which the website stores on your computer, phone or other device. "Cookies" files are necessary to facilitate browsing and to simplify it, and they do not harm the computer in any way.

Although we use the general designation "cookies" in these Rules, since they are the main way of storing information used by the site, the "local storage" space in the browser is also used for the same purpose as "cookies". All information in this section also refers to "local storage". "Cookies" files are an essential part of the site's functioning. The main purpose of our cookies is to improve your browsing experience. They are used, for example, to remember your preferences (language, country, etc.) when browsing and on future visits. The information collected by cookies also allows us to improve the site by estimating the number and patterns of use, its suitability for individual user interests, faster searches, etc. Occasionally, if you have given us your prior informed consent, we may use cookies, tags, and similar information-gathering devices to enable us to display to you, either on our own site or on a third-party site or otherwise, advertising based on an analysis of your browsing habits.





We do not store sensitive personal information such as address, password, credit or debit card data in the "cookies" files we use. The information stored in the "cookies" files from our site is used only by us, with the exception of the files identified below as "external cookies", which are used and managed by external entities to provide the services requested by us aimed at improving our services and the user's experience when viewing the site. The main services for which we use the mentioned "external cookies" are obtaining access to statistics and ensuring the execution of payment operations. If you want to avoid the use of "cookies" files on the site taking into account the above restrictions, you must first disable their use in your browser and then delete the "cookies" files stored in the browser connected to this site. You can use this option at any time to prevent the use of cookies. You can limit, block or delete cookies from this site at any time by changing your browser configuration. Although each browser has different settings, cookies are usually set in the "Preferences" or "Tools" menu.
